Students interested in contesting the election may go through the guidelines and submit their nomination with the consent of the parent to the respective class teacher on or before 28 April 2024.

### Guidelines for students - Election to the Student Council 2024- '25

All Students from Grades V to XII are eligible to contest for election to the School Council.

- 1) The candidate should have a proven academic record with at least 61% aggregate marks in the previous class and proven co-scholastic achievements to his/her credit.
- 2) Must have good and effective communication skills and leadership qualities.
- 3) Must be willing to serve the school in enforcing discipline.
- 4) Must be confident and be able to present matters concerning class /students in the Council meetings with conviction.
- 5) Candidate must be knowledgeable about discipline rules/guidelines as given in the school diary.
- 6) Must have good character, conduct and deportment matching with the tradition and values of the school.
- 7) Should be able to attend Student Council meetings without fail.
- 8) Selection will be based on informal election in the classroom, student's behavior, academic performance, and teachers' feedback.
- 9) A student who has a serious indiscipline issue reported against her/him will not be eligible.
- 10) Failure to fulfill a Council member's duties and responsibilities and inappropriate behavior shall result in forfeiture of the position and the badge.
