- For KG 1 Non-sibling students from 18/11/2023 to 19/11/2023.

#### The following are the Terms and Conditions:

- 1. The applicant child must have a valid Qatar Residency Permit.
- 2. The child's age for KG I should be minimum 3 years and should not exceed 4 years 5 months and 29 days as on 31 March 2024, as per the specification by MOEHE.
- 3. Name of the child should be entered in the Online Form as per the child's passport (Given name followed by surname)
- 4. The Data submitted online will be carefully scrutinized. If any false information is provided, the application will be considered invalid and it will not be eligible for further process.
- 5. For KG I admissions, siblings will be given preference (Cousins will not be considered as siblings).
- 6. Successful submission of this online form does not guarantee admission.
- 7. Do Not use personal reference for enquiries & taking admission. Only online enquires will be considered.

- 1. On successful completion of the form, an automated enquiry id will be generated and will be displayed on the screen which may be noted for your future communications.
- 2. If the submitted data for KG I is accepted by the school, the parent will receive an email from <a href="mailto:admission@bpsdoha.com">admission@bpsdoha.com</a> by 28/11/2023 (To avoid overlook of our mail, please check the Inbox, Junk box and Spam box)
- 3. In case of no updates from the school by **28/11/2023**, please contact the school on **29/11/2023** for the status of KG I applications only.
- 4. For other classes, parents will receive an email for the status of their application latest by 01/03/2024.

- 1. Use Mozilla Firefox browser for better access of the online link.
- 2. Documents that are helpful for filling out the Online form are as follows:
  - Passport of the Child
  - Qatar ID of the Child
  - Sibling Child's admission number
- 3. All the fields with asterisk (\*) are mandatory to be filled.
- 4. Avoid multiple entries using all sibling's admission numbers (use only One)
- 5. More than one person attempting for the same child must be avoided.
